## HOSPITAL / INDUSTRIAL TRAINING NOTICE (B. Pharmacy 6<sup>th</sup> Sem. Students)

As per PCI and CSVTU curriculum, every candidate shall be required to work for at least 150 hours spread over four weeks in a Pharmaceutical Industry/Hospital. It includes Production unit, Quality Control department, Quality Assurance department, Analytical Laboratory, Chemical manufacturing unit, Pharmaceutical R&D, Hospital (clinical Pharmacy), Clinical Research Organization, community Pharmacy, etc. After the Semester 6<sup>th</sup> and before the commencement of Semester 7<sup>th</sup>, and shall submit satisfactory report of such work and certificate duly signed by the authority of training organization to the head of the Institute.

In the view of above, it is to inform you all that this Training is Desirable, so students of 6<sup>th</sup> sem. who wish can apply for 4 weeks Hospital/Industrial Training, **with effect from 01 June to 30 June 2026 (tentative).**

### Following are guidelines for the same:

- 1) Students have to select Industry/Hospital of their choice & after ascertaining that Industry/Hospital is ready to impart training as per required norms, students can take guidance from faculty members or T&P Coordinator.
- 2) For a particular Industry/Hospital, application should be in a group of 4 to 10 students.
- 3) Name, Designation, Telephone number & office postal address of responsible official of Industry for training should be informed to T&P coordinator, in prescribed format with undertakings. In addition to Training charges, if any, students will have to make their own arrangements for travel and accommodation.
- 4) Students have to submit the Application form along with the Undertaking form to T&P Coordinator on or before 20 May 2026. In no case, choice shall be accepted after 20.05.2026.
- 5) It is important to note that, student can take admission to next semester, only after submitting Two copies of Training Certificates, along with Project Report to respective T&P Coordinator.
- 6) If University's Examination Time Table for 6<sup>th</sup> sem. is scheduled during Training, he/she must have to reschedule their training after completion of their University Examination.
- 7) Students are advised to choose Highly Skilled Training Institutes, to ensure quality training in relevant field.
